Unfortunately, Ehlena's school protested her having Wonder with her, and so Sam sued on her behalf, taking the case all the way to the US Supreme Court. Ehlena and Sam prevailed, winning a huge victory for the rights of persons with disabilities all over the U.S.

When the Flint Water Crisis occurred, Sam knew that Flint families deserved accountability for their injuries. Sam scored a huge victory in federal court to allow residents affected by the water crisis the ability to hold officials accountable for their wrongs.



PROPOSAL 18-1

A **YES** vote on Proposal 18-1 will legalize and regulate the recreational posession and use of marijuana under state law. If passed, a regulatory structure would be set up similar to how other controlled substances, like alcohol, are currently established.

PROPOSAL 18-2

A **YES** vote on Proposal 18-2 will create an independent citizen commission for the purposes of drawing district lines for the Michigan House of Representatives, Michigan Senate and United States House of Representatives. The current the Michigan House of Representatives and Michigan Senate to draw their 4 Democrats, and 5 to be independent or third party voters. The commission certain criteria, including compliance with federal laws; equal population sizes; geographic contiguousness; demographics and communities of interests; no advantages to political parties; no advantages to incumbents; municipal boundaries; and compactness.

PROPOSAL 18-3

A **YES** vote on Proposal 18-3 will add several voting options and policies to the Michigan Constitution. These include:

- Straight-party ticket voting option
- Automatic voter registration
- Same-day voter registration
- No-excuse absentee voting for 40 days before an election
- Voter registration by mail up to 15 days before an election
- Ensure active-duty military members and overseas citizens receive an absentee ballot 45 days before an election
- Allowing an audit of election results
- The right to use a secret ballot
